This one-year top-up course is for those who already have qualifications (Level 4 and 5 or 240 credits) or experience in a relevant field and wish to gain a degree in business management. The course delivers an industry-relevant degree that provides a broad understanding of core business management across a variety of organisations, situations and operating conditions. Successful students will be awarded a BSc. Business Management (Hons.) degree from the University of Bedfordshire (UK).

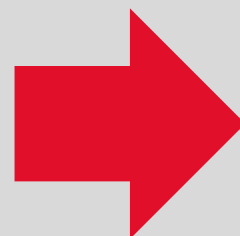

FAST TRACK

Students with two CAPE or A-Levels can study ABE Level 5 courses and gain direct entry into the BSc Business Management (Hons.) Degree. The chart highlights the different entry routes:

HOW WILL I BE ASSESSED?

Assessment takes a variety of forms, including reports, portfolios, individual and collaborative tasks (individually assessed), research proposals, poster presentations, and exams.

ENTRY REQUIREMENTS – This Level 6 course is for applicants with a related Foundation Degree, Level 5 Diploma (ABE) or Higher Education qualification wishing to top up, in one year, to the full BSc (Hons.) Degree. Supervisory experience is also considered along with academic qualification for experiential learning application.

Duration: 1 Year

Classes will be held on weekend on both Saturday and Sunday from 9am-4pm, with alternating evening sessions.

COST: \$606,000 (varies according to exchange rate)

Payment plan available- Paid over 6 installments (3 installments of \$153,000 each and 3 installments of \$44,000 each)
